# Neighborhood Block Party Permit Terms and Conditions

**The following special terms and conditions shall be in effect for the duration of the block party permit:**

1. "Road Closed" barricades must be placed across the entire road at each closure and be of the movable type to provide access for ambulance and fire apparatus.
2. Maintain a 20' fire lane at all times. Do not place fixed items in the street area for any activities; all items must be portable in case of emergency.
3. Assign monitors at each street closure to allow access for neighbors and emergency vehicles.
4. Public access must be allowed for neighbors not attending the event.
5. The entire area shall be maintained in a clean and litter-free condition.
6. All decorative materials shall be fire resistant and flame retardant.
7. Noise level shall be kept at a minimum and adhere to City Noise Regulations (BMC chapter 8.26).
8. The name and telephone number of the applicant will be provided to the Bothell Police Department.

# Neighborhood Block Party Guidelines

The City of Bothell issues Block Party permits for neighborhood events that temporarily close a street. The permit process is started by obtaining a permit application at [www.bothellwa.gov](http://www.bothellwa.gov) and submitting it to the special events coordinator at the Bothell Police Department.

## HOST A NEIGHBORHOOD BLOCK PARTY

Applicants are responsible for contacting affected neighbors to share the details of the street closure, event and clean up. Applicants are also responsible for providing temporary barricades and street closure signs. Closure signs for a Neighborhood Block Party can be posted on recycling bins or other movable items.

### To host a Neighborhood Block Party, you may not:

- Close an arterial street
- Close an intersection
- Close a street with a bus stop
- Place fixed items in any street

## APPLICATION

The application must describe your activities and include the following information:

- Date of your event, with beginning and ending times. Block parties can only be held between 8:00 a.m. and 10:00 p.m.
- The estimated number of people you expect to attend.
- The name, address, and telephone number of the contact person.
- A map of the area you intend to close.

Your application and fee of \$30.00 must be received by the City of Bothell a minimum of 30 days prior to your planned Neighborhood Block Party. You can expect to receive notification of your permit status within 14 business days of submittal. Once a block party permit is issued, you are welcome to close your street during the timeframe indicated on the permit. If a complaint is received, a police officer will be sent to the location to assess the situation.

## NATIONAL NIGHT OUT

Each year, the City of Bothell celebrates National Night Out, a nationwide campaign to raise awareness of crime and drug prevention. Fees are waived for neighborhoods holding block parties in conjunction with NNO in an effort to strengthen neighborhood spirit and support increased awareness. The Bothell Police Department also hosts an event on National Night Out and all Bothell citizens are invited. ### Here is an example of how to block off your street, once you receive a permit:

- Place barricades with “ROAD CLOSED” signs across the entire roadway at each closure
- Keep tables/fixtures to one side of the street in order to maintain a 20’ fire lane
- Assign a monitor at each closure to remove temporary barricades/signs for neighbor access and emergency vehicles.
